MSF2 and an update on MSF3

Five authorities have beaten the June 3rd deadline to award more work through the Medium Schemes Framework 2 (MSF2). The framework has been now used to award 40 package orders across the Midlands. Overall, MSF2 has been used by more authorities, to deliver a greater value of work whilst achieving bigger savings.

Further details of this successful framework will be reported at the MHA Annual Conference in September.

Meanwhile, colleagues from eight authorities from across the region are helping to assess the tenders received for the replacement framework MSF3.

An announcement is expected next month, with the launch of the new framework planned for the Annual Conference in September.

MHA shortlisted for NEC award

The MHA has been shortlisted for the NEC Client of the Year award at this year's NEC Awards event, with the winner due to be announced the NEC Users' Group Annual Seminar 2018, in London on 20 June. Look out for news of the verdict in our next newsletter.


