#### **PSP 4 Tender – now live!**

Please be aware that the PSP 4 Tender was issued on 21 February and is now live.

The closing date for submissions is 12:00 midday on 05/04/23.

Whilst we have evaluators already identified for the evaluation panels, there is still an opportunity for local authority members with experience of using the PSP 3 framework to volunteer. It is a good development opportunity and MHA+ will compensate an authority for staff time spent on procurement projects. Please contact the MHA+ Manager by 17 March at the latest to register your interest.

### **Protect your access to the Frameworks**

Following the merger to create MHA+ in July 2020, existing MHA members were required to complete a 'Deed of Variation', and non-MHA members to complete a 'Deed of Adherence' to become members of MHA+. Despite all existing members making an informal commitment in writing, a few members still need to complete the formal paperwork.

Please note that we are currently reviewing the membership records in conjunction with our legal department.

Some 20 members used MSF 3 and 30 Members are currently using PSP 3. Any member authorities who are intending to use MSF 4, or the new Professional Services Framework in August, will need to ensure that their membership paperwork and membership fees are up to date.

**SIG Updates (Nov 2022 – Feb 2023)** 

There have been 8 Service Improvement Group meetings since the last update in October 2022. We continue to have excellent levels of attendance and participation from group members across the MHA Plus region and look forward to a full programme of SIG meetings in 2023.

**Streetworks** – The first meeting for this group since November 2021. Many thanks to the outgoing chair Gez Romano (Warwickshire CC) and also to the new group chair, Josh Pemberton (Leicester City).

**Civil Parking Enforcement –** Updates from group members on their plans to apply for Moving Traffic Enforcement powers in Tranche 2 (January 2023). Further discussions and sharing of best practices around cashless parking and virtual permits.

**Flood Water Management –** Excellent attendance at this meeting with members actively sharing case studies, proformas, guidance, and planning conditions with their colleagues on the topics of enforcement, project management/funding streams, SUDS, and flood resilience.

**Street Lighting** – An in-person meeting that was combined with an ILP Birmingham event which many group members were attending. In addition to the SIG meeting, members were able to attend two seminars and take a tour of the Fabrikat factory in Sutton in Ashfield.

**Highway Asset Management –** DfT reps James Brett and Gary Kemp attended to update group members on the work they are doing to build a standard for national highway condition data collection and provide a general update regarding funding and self-assessment. Xais also presented on their footway condition surveys which can be undertaken using a mobility scooter that can be driven along the footway rather than surveying from the carriageway.

**Traffic Signals –** Presentation from Andrew Walsh at TfWM about the Birmingham 2022 Commonwealth Games Traffic Management Programme, the establishment of a Games Route Networks and, traffic signal operational strategy.

#### **MHA+ Members Fee**

Local Authority membership of Midlands Highways Alliance Plus (MHA+) is subject to an annual membership fee of £3,750 which covers alliance running costs.

We've received nine payments to date and would like to remind those who haven't yet paid, to please ensure that we have up-to-date contact details so that orders can be raised, and invoices paid by 31 March 2023, to avoid placing your membership benefits at risk.



Alliance membership allows a member authority access to benefits including:

- A collaborative community of client, consulting and contracting professionals
- Staff development through active engagement in governance, working groups, etc.
- Free training via the free Learning Management System (LMS)
- Free shared learning opportunities e.g., supplier training, learning library, working groups
- Free Annual Conference event with the opportunity for networking, learning, and self-promotion

- Free Service Improvement Group (SIG) network of 16 highways and transport specialist groups and supporting website (previously MSIG)
- Medium Schemes Frameworks (MSF 3/4) where terms and conditions agreed
- Professional Services Frameworks (PSP 3/4) where terms and conditions agreed
- Information via the website, information sharing platform (ISP), newsletters, and meetings
- Support via core team and supplier contacts

The Future Highways Research Group (FHRG) recognises that local highway authorities demonstrating the greatest value for money are active members of alliances such as MHA+.

Persistent non-payment of membership fees will ultimately undermine the services MHA+ are able to offer and increase future membership fees. Non-payment is now routinely reported to the Programme Board. All local authority Directors with outstanding fees due will be written to and continued non-payment will be escalated to the Executive Board with a recommendation on further action to be taken.

#### **MSF 4 Procurement Fee**

The below highlights the MSF 4 procurement fee for each scheme that is put through the framework:

- 0.25% of the 'value of the work order' at the start of construction
- Minimum fee of £2,500 and a maximum fee of £50,000
- MHA+ Annual Membership Fee of £3,750 will be deducted from the MSF 4
   Procurement fee once a year

This is generated when a scheme reaches stage 2 – 'construction', and an annex C is completed.

# **Live Labs 2 – the success of Transport for West Midlands bid**

The MHA+ with its Carbon Steering Group have supported the successful bid put forward by (TfWM).

TfWM's Mark Corbin (Director of Network Resilience) said:

"We are truly delighted to be part of the **ADEPT** Live Lab 2 programme. Our



focus over the three years of our Live Lab will be the creation of a UK Collaboration Centre of Excellence for Decarbonisation of Materials. This will provide a centralised hub for research and innovation for the decarbonisation of highways. It will be one programme across two campuses – the north campus will be hosted by **North Lanarkshire Council** and we at **Transport for West Midlands** will be the south campus.

Together with our industry partners, academic institutions, and public sector bodies, we will develop a knowledge bank, test materials in real-life conditions, share learning and embed new approaches and materials across the highways sector. This is a significant opportunity to shape the future and for the UK to be a global leader in this space and we are truly excited to be on this journey."
