Carbon Steering Group (CSG) update and look ahead

The CSG continues to provide a focus for all things pertaining to Carbon Reduction and Net Zero for MHA+. So, what is going on in the CSG, below are some of the items covered at the last meeting and topics coming up at the future meeting:

- The National Highways & Transport Network (NHT) are liaising with the CSG membership over their development of a carbon tool to assess the 'Value of Carbon' in Highways for Local Highway Authorities. They provided an update on progress so far including the development of a forecasting tool.
- Carbon and Transport Business cases Atkins provided an interesting
 presentation on Carbon and Transport Business cases, in particular detailing the
 key processes and benefits in terms of potential for carbon reduction, whole life
 cycle carbon impacts, shifts in DfT guidance and links with Active Travel and shared
 transport approaches.

- Active Travel A range of topics were covered in relation to the active travel agenda. Group members discussed the challenges and successes in developing active travel projects and the potential for pooling resources and further sharing of projects and experiences between authorities.
- Local Authority Development Design Guides Andy Jackson from Leicestershire County Council (LCC) shared his work on the review of the LCC Design Guide, part of which focusses on carbon reduction and the potential for use of more sustainable materials, local sourcing and green infrastructure.
- **Devon County Council Carbon Measurement** Victoria Walsh will be attending the next meeting in October to provide an update on Devon's ground-breaking approach to measuring carbon in relation to all things Highways.


Here is a snapshot of some of our members and suppliers' recent awards:
