The Procurement Act 2023

The new Procurement Act 2023 is expected to come into force this autumn. Guidance can be found from the <u>Government website</u>. The Procurement Act 2023 will consolidate over 350 different procurement regulations into a single regime that applies to most central government departments, the wider public sector, and contracts awarded by utilities companies.

The Act doesn't change the fundamental requirements for procurement or the principles and objectives of delivering value for money, maximising public benefit, transparency and acting with integrity that must underlie the awarding of a public contract. It does, however, introduce some additional flexibility which will be helpful in letting new contracts and in renewing our frameworks in the future.

We will of course review any guidance issued on good management practices and assessment of supplier performance to assist in meeting our aspirations for continuous improvement.

The Cabinet Office has developed a short guide outlining the comprehensive, centrally funded learning and development package for contracting authorities. The <u>update</u> on the official learning and development offer for contracting authorities will help you decide which of the learning and development options are most suitable.

New ADEPT/COLAS employee retention guide

A new guide has been published to offer insights and help to encourage staff retention in local authorities across the country.

Employee Retention

A <u>great practice guide</u> has been developed in partnership with ADEPT/Colas. The guide includes examples from MHA+ member authorities that featured as part of the 2023 MHA+ annual event. The MHA+ Skills and Development Lead undertook an analysis of workforce data and retention was highlighted as a key issue, particularly at senior engineer and team manager levels.

Service Improvement Group (SIG) Update

There have been 8 Service Improvement Group meetings since the last update in October 2023. We continue to have excellent levels of attendance and participation from group members across the MHA Plus region. Agendas, minutes and presentation slides from all SIG meetings are available on the <u>MHA Plus SIG</u> <u>members website</u> along with benchmarking exercises and online discussion boards.

Highways Records & Services

The List of Streets (LoS) task group presented their initial findings from a countrywide survey about current practice in terms of maintaining and updating the LoS. Group members agreed to undertake an update of a 2008 reference document on Highway Terms and make this resource available to all MHA Plus members

Third Party Claims

Group members discussed increases in claims for vehicle damage over the course of the year, particularly since recent wet and cold weather conditions. Discussions also took place around reviewing intervention levels in light of ongoing budgetary pressures and how to deal with and identify fraudulent claims.



Street Lighting

This meeting was held in-person at the TRT Lighting factory in Redditch, followed by a factory tour. Discussions took place on vandalism to lighting assets, energy costs, EV charging from lighting columns and the perennial issues with festive/seasonal attachments to columns.

Traffic Signals

Darren Capes from the Department for Transport (DfT) ran through the details of the £70m local authority funding for traffic signals recently announced. The funding is to replace obsolete signal equipment, reduce congestion by introducing smarter signals and put forward innovative solutions, such as the use of AI and machine learning.

Highways Asset Management



Group members shared their thoughts on how to meet the reporting requirements set out as part of the recent Network North Highway Maintenance uplift from DfT. Mark Evans provided a demonstration of how Leicestershire County Council are using Vaisala's Road AI software tool to manage assets across their highway network.

Term Maintenance

Presentations on Vaisala Road AI (Leicestershire County Council) and Lincolnshire's Operational Control Hub in collaboration with Balfour Beatty. Sharon Andrews from the National Highways & Transport Network attended to discuss how the group maximise the use of <u>NHT's</u> CQC <u>Efficiency Network</u> and Public Satisfaction data to drive service improvements and value for money.

Civil Parking Enforcement

Group members discussed the implications of the recently published the <u>DfT 'Plan</u> <u>for Drivers'</u>. They provided updates on Moving Traffic Enforcement, parking charges, CEO recruitment, current financial pressures and whether they were planning to move to the National Parking Platform (NPP). A small sub-group will be set up to discuss the NPP and cost/service implications for local authorities.

Winter Services

Paul Wilkins from Devon County Council kindly provided a presentation on the cycleway winter treatment trials that had taken place in Exeter. A copy of the presentation slides is available on the <u>SIG members website</u>.

Carbon Steering Group (CSG)



The CSG continues to provide a focus for all things pertaining to Carbon Reduction & Net Zero for MHA+. A couple of items of interest are:

- Carbon News Bulletin The first bulletin of 2024 is due out soo so watch this space for interesting items regional, national and beyond. The previous carbon news bulletins can be found on the <u>MHA+ website</u>.
- Journey to Net Zero presentation Paul Binks from Lancashire County Council & Vice Chair of the CSG provided a presentation over the journey to Net Zero for Lancs and referenced some interesting statistics from the national ALARM Highways Survey on where MHA+ Member Authorities are in relation to carbon. A key feature was the 'Propensity to Change' for local authorities and how this might be pursued in terms of progression in materials and efficiency etc.
- The National Highways & Transport Network (NHT) Presented progress with their 'Value of Carbon' Tool in Highways for Local Highway Authorities in relation to MHA+ member LA's who are also members of the NHT/CQC with a view for member LA's to consider sharing their key successes and approaches where they scored well via the tool.
- Live Labs 2 Tracy Cowley from Transport for the West Midlands provided an update on progress with the Centre for Excellence & detailed that there will be an Expo event for Live Labs 2 on Low Carbon Adaptation hosted in Birmingham on 17 April 2024.

Social Value Working Group



The Social Value Working Group (SVWG) covers a wide range of issues in relation to Social Value.

- Measuring Social Value A positive meeting was held with the Considerate Constructors Scheme (CCS) team over progressing a way forward in adding to the effective measurement of social value in projects. A national working group is being set up to progress this with MHA+ with the SVWG having a direct input.
- **Employment & Skills** Following on from the social value workshop at the MHA+ Annual Event the SVWG are looking at key elements in how MHA+ can help its members. This will be a main topic for the March 2024 meeting

Digital Working Group

The Digital Working Group (DWG) provides coverage on all things digital (including BIM activity), supporting members in their digital journey through its events and workshops in 2024, including:

- **The Big Digital Event** A one day in person digital event in May 2024, which will cover digital in design, construction and maintenance, including 3D printing in construction & Highways Data systems/surfacing.
- A series of short online workshops focussing on problem solving on key practical digital issues. The DWG is keen to use one of the workshops as an opportunity to liaise with a major project team to understand how best to utilise digital tech to further enable project development and delivery. - Changemaker3D who have worked out how to make 3D concrete printing relevant to highways
- Highway Data Systems who have technology that eliminates the need for technicians when surfacing
