

## Becoming a member of MHA+

The list of documents shows that as a new member you will need to sign the MHA+ Deed of Adherence which refers to:

- the original MHA Agreement and
- the MHA+ Deed of variation showing the changes from the MHA agreement to the MHA+ agreement with the merger.

Both of these documents are in the list of documents you can download (just click once).

Some legal teams may be concerned with the lack of date on the MHA+ documents.

The date was to be added when all the original MHA members had signed, but 2 authorities have still to return a signed copy.

The merger was effectively in July 2020 so 31 July 2020 would be a reasonable date to use if it can't be left blank for now.
