The MHA was the first partnership of its kind in the UK which commenced in July 2007. The MHA are an 'Unincorporated Association by Agreement' and currently have a membership comprising local authorities and Highways England. A full list of members can be found here <http://www.mhaweab.org.uk/about-us/membership/> MHA members share a common goal: to improve performance, share best practice and make efficiency savings in the delivery of highway services by working together. As a collective the MHA estimates (but does not guarantee or warrant) a total spend of approximately 250 000 000 GBP (Based on spend put through the MFS2 framework agreement a predecessor of MSF3) on the delivery of highways schemes during the lifetime of the framework agreement.
