MSIG, MHA, WMHA merger update

The working group is continuing to make good progress and following consultations with all the authorities involved a report on the merger will be presented to the Executive Board meeting on 19 March.

Subject to that being approved, the new organisation will go live from 1 April 2020. The new organisation will be known as MHA Plus. In true Brexit style a 12-month transition period will be used to align the various task groups with the new way of operating and to ensure that the best of all three organisations communications activities are pulled together.

The latest version of the **MHA Performance Management Toolkit** (version 3 - dated 6 January 2020) is now available on the website.




